Please include a check, made payable to CDAODTC, for the required camping fee. Checks will not be deposited until after checking in with the trial chairman on Saturday, and will be returned if the exhibitor decides not to camp.

**ENTRY FEE** is \$20 for the first entry, \$12 for the second entry of the same dog, per day (includes AKC recording fees of \$3 for the first run, \$1 for each additional run). Mail entries, maximum of 10 per envelope, with fees payable to CDAODTC, to Beth Elliott, 9N909 Koshare Trail, Elgin, IL, 60124. Envelopes containing more than 10 entries will be returned in their entirety. Express mail entries must waive the signature requirement or they will be refused!

Exhibitors are responsible for complete, accurate, and legible information on their entry forms, and the correct entry fee. Please do not use staples to attach checks and/or height cards to your entry! Checks returned due to non sufficient funds will be assessed a \$25 fee. All illegible or incomplete forms, or those with insufficient entry fees, will be returned, no attempts by email or phone will be made!

Notification of entry status prior to closing will be emailed to all exhibitors providing an email address. Any exhibitor that does not have an email address should send a SASE or postcard to be returned with their entry status information. No other acknowledgment of entry status will be given! Exhibitors with email addresses are responsible for making sure their email address is legible and that any mail from the trial secretary is not blocked by spam blockers or rejected due to a full mailbox. No further attempts will be made to resend any entry status email that is returned or rejected!

Final entry confirmations and judging schedules will be sent after the final closing date to all exhibitors, as per Chapter 1, Section 18 of the Regulations for Agility Trials. Exhibitors providing an email address will be emailed their confirmations, exhibitors with no email address will be sent their confirmation via the US Postal Service.

**DOGS ELIGIBLE TO ENTER:** This trial is open to all dogs 15 months or age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Indefinite Listing Priviledges or approved FSS breeds, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate.

**PRIZES AND AWARDS:** Rosettes will be awarded to the 1st through 4th place dog in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. A MACH bar and MACH ribbon will be awarded to any dog and handler earning their MACH title at this event. No ribbons or prizes will be mailed.

**MEASURING:** All dogs that do not have a permanent or valid temporary jump height card issued by the AKC must be measured by the VMO attending this trial prior to competing.

**CLASSES:** All Standard and Jumpers with Weaves titling classes will be offered. There will be no FAST, ISC or non-regular classes at this trial. Electronic timers will be used.

**HEIGHT DIVISIONS:** Owners are responsible for entering the proper height divisions. Judges reserve the right to measure all dogs without a valid height card. Handlers may opt to run in a higher height division in the Regular program, but not in a lower division than their proper height division. Handlers must run in their proper height division in the Preferred program.

**NOTICE TO EXHIBITORS:** Entry fees will not be refunded in the event that a dog is absent, excused, disqualified, or barred from the competition by action of the Show Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. Any bitch that comes into season after the closing date may have their entry fee returned, less \$5 per run administrative fee, by providing the trial secretary with a signed statement from a veterinarian at least ½ hour before judging begins. There will be no refund for injured dogs after the closing date.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such cases, no refund of any fees paid will be made.

Dogs are not required to be at the trial until the scheduled time of judging, however handlers arriving after the scheduled course walk through for their class has taken place are not guaranteed a chance to walk the course. All dogs not needed for further judging are excused. The owner/handler is solely responsible for having it ready at ringside when the class is to be judged. Conflicts between rings should be discussed with the judge prior to the start of the class and the gate steward notified.

Exhibitors and spectators are expected to keep the show grounds clean. Please pick up after your dogs. Anyone witnessed not picking up after their dog will be excused from the trial weekend with no monies refunded. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Exhibitors are required by Boone County and the state of Illinois to maintain proof of either rabies vaccination or titer.

This club does not agree to arbitrate claims as set forth on the official AKC entry form for this event.

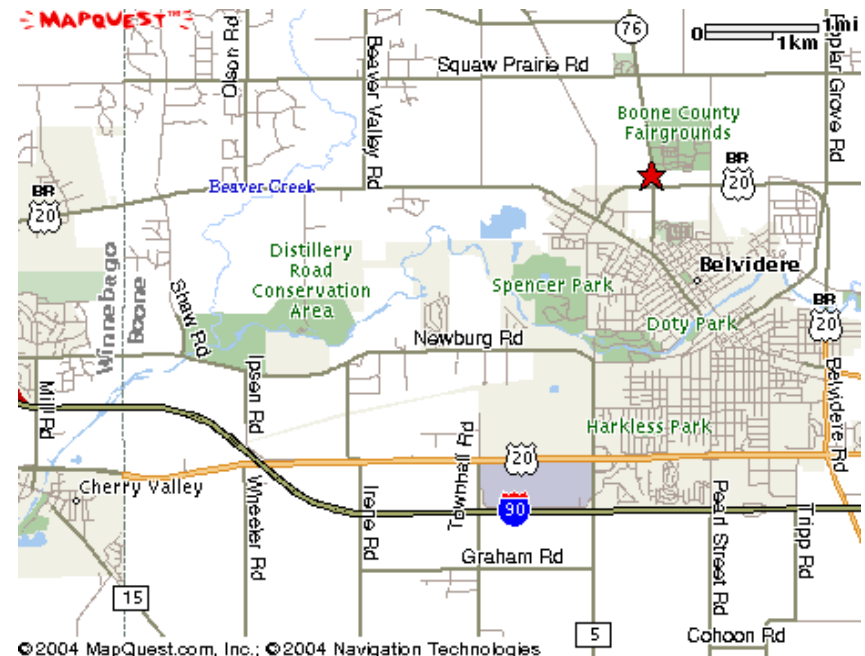
**CATALOGS/RUNNING ORDERS:** Running orders will be available each day to all exhibitors. Full catalogs will be available by presale, with a limited number on hand for sale the day of the trial. **SITE INFORMATION:** The agility trial will be held at the Boone County Fairgrounds, 8791 Route 76, Belvidere, IL. This trial will be held outdoors on grass with indoor crating available. Camping will be allowed on site, motor homes and tents, for \$30 per night. Checks should be made payable to the club, and either returned with your entry or sent directly to the trial chairman, Jean Munger. Any additional questions regarding the site and its amenities should be directed to the trial chairman.
