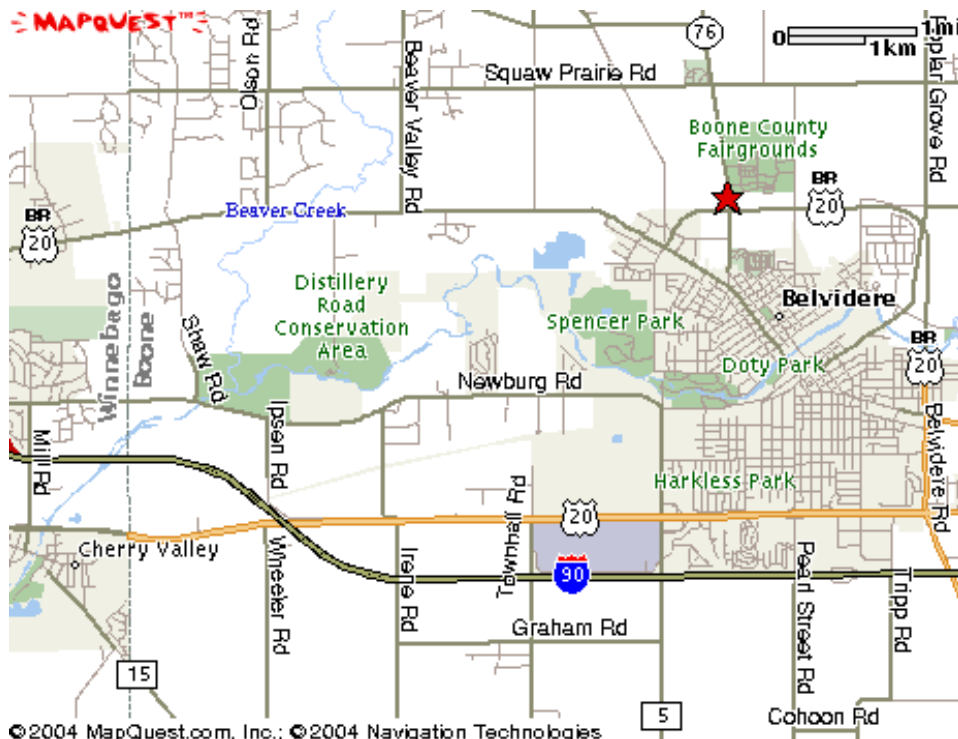
Except for the first class of the day in each ring, all start times are approximate. Dogs in the "B" classes will run first, followed by dogs in the "A" classes for each jump height. Dogs in the Preferred program will run after dogs in the Regular program in their corresponding jump height. Walk throughs for Excellent will be split as follows: Standard - 8"/12", 16", 20", 24"/26"; Jumpers - 20", 24"/26"/4"/8"/12", 16".

There will be an AKC Volunteer Measuring Official at this trial. Any exhibitor who did not submit a jump height card with their entry must present their height card to the Trial Secretary or else be measured by the VMO prior to receiving their armbands. All exhibitors with height cards on file (noted on your entry confirmation) may pick up their armbands at the trial and need only check in with the gate steward for their class. If you need to have your dog measured by the VMO, you will need your registration information to fill out the form. Please bring it with you, as I will not look it up for you!!

DIRECTIONS: Take I-90 to Rockford and exit at exit at Genoa Road and go north. Genoa Road will turn into Belvidere Road. Follow Belvidere Road to IL Route 76, and turn right onto 76. Fairgrounds will be on the right side.
