| 1 | A-1 is dribbling in the backcourt and ends his/her dribble. A-1 is immediately doubled teamed and the defensive pressure prevents a pass to A-2. A-1 intentionally bounces the ball off of one the defensive players and recovers the ball and starts another dribble. Official rules this a double dribble. Is the official correct? | 1 | No | Rule 9 Section 5 Art 2 |
| 2 | A-1, in an attempt to save the ball from going into the backcourt, jumps into the air. Seeing that he/she will land in backcourt with the ball, A-1 requests a time-out. Official denies the request. Is the official correct? | 2 | No | Rule 5 Section 8 Art 3a |
| 3 | During an alternating possession throw-in by team A, thrower-in A-1 commits a throw-in violation. Official awards the ball to team B and has the scorer turn the arrow toward team B's basket. Is the official correct? | 3 | Yes | Rule 6 Section 4 Art 5 |
| 4 | With three-tenths of a second remaining in the game, A-1's throw-in is caught by A-2, who is fouled as he/she throws the ball toward his/her basket. The foul occurred before the signal sounds indicating time has expired. Team A is in the bonus. Official awards A-1 a one and one. Is the official correct? | 4 | Yes | Rule 6 Section 7 Art 7 Exception c, Rule 4 Section 8 Art 1a, Rule 10 Section 6 Penalty 3a Rule 5 Section 2 Art 5, Case Book 2007-08 Play 5,2,5c |
| 5 | A-1 is bleeding and the official directs A-1 to the bench to be replaced. Team A has one 60 second time-out remaining and one 30 second time-out remaining. The coach signals the official he/she wants a 30 second time-out to keep A-1 in the game. Official rules a 30 second time-out may not be used if a 60 second time-out remains. Is the official correct? | 5 | No | Rule 3 Section 3 Art 6 |
| 6 | Team A is granted a 30 second time-out. With fifteen seconds remaining in the time-out, the timer sounds a warning horn. Is the timer correct? | 6 | Yes | Rule 2 Section 12 Art 4, Rule 5 Section 11 Art 2 |
| 7 | During an alternating possession throw-in by team A, A-1's throw-in is touched by B-1, who has a foot on the boundary line. Official rules this a violation on team B and instructs the scorer to turn the arrow toward team B's basket and awards team A the ball nearest the spot where B-1 touched the ball. Is the official correct? | 7 | Yes | Rule 7 Section 2 Art 2, Rule 6 Section 4 Art 4, Rule 4 Section 42 Art 5 |
| 8 | A-1 and B-1 commit a double personal foul while A-2 is holding the ball near the division line. Official awards the ball back to team A for a throw-in at the spot nearest to where the ball was located when the double personal foul was committed. Is the official correct? | 8 | Yes | Rule 4 Section 36 Art 2a |
| 9 | A-1 is in the act of shooting when B-2 fouls A-2. A-1 continues the motion and scores. Official disallows the basket. Is the official correct? | 9 | No | Rule 6 Section 7 Art 7 Exception c, Rule 4 Section 11 Art 1&2 |
| 10 | A-1's try is in flight when time expires in the first quarter. Before the try ends, B-1 is assessed with a technical foul. Official starts the second quarter with team A attempting the free throws for the technical foul. Is the official correct? | 10 | No | Rule 5 Section 6 Art 2 (3) |
| 11 | Following a field goal and while the ball is at the disposal of team B, A-1 commits a common foul near the end line. Team B is not in the bonus. Official awards the ball back to team B and rules this a designated spot throw-in. Is the official correct? | 11 | No | Rule 7 Section 5 Art 7b |

| 12 | While the ball is in flight on a throw-in by A-1, A-2 commits a common foul on B-2. Team B is in the bonus. Official rules this a team control foul and awards no free throws. | 13 | During a jump ball to start the overtime and before either team gains control, B-2 commits a common foul on A-2. Team A is in the bonus. Official instructs the scorer to set the possession arrow when the ball is at the disposal of A-2 for the first free throw. Is the official correct? | 13 | Yes | Rule 4 Section 3 Art 2 |
| 14 | Following a field goal by team A, team B's throw-in is deflected out of bounds over the end line. Official awards the ball back to team B and rules this is a designated spot throw-in. Is the official correct? | 14 | Yes | Rule 7 Section 5 Art 2, Rule 7 Section 5 Art 7b |
| 15 | Contact occurs between airborne shooter A-1 and B-1. The try is successful. One official rules a foul on A-1 and the other official a blocking foul on B-1. Official disallows the basket and uses the possession arrow to resume play. Is the official correct? | 15 | No | Rule 4 Section 36 Art 2b, Case Book 2007-08 Play 4.19.8C Page 29 |
| 16 | Following a time-out, A-1 is to attempt a one and one but delays entering the semi-circle when the official is ready to administer the free throw. The official uses the resumption of play procedure to resume play. Is the official correct? | 16 | Yes | Rule 4 Section 38, Rule 8 Section 1 Art 2 |
| 17 | The head coach of team A requests a time-out while a player of team A has control. Official denies the request ruling only a player may request a time-out while the ball is live. Is the official correct? | 17 | No | Rule 5 Section 8 Art 3 |
| 18 | A-1, in the frontcourt, is closely guarded. The official has a count of two when A-1 starts a drive directly to the basket. A-1 has his/her head and shoulders in advance of B-1. Official continues the count. Is the official correct? | 18 | No | Rule 4 Section 10 |
| 19 | Following a score by team A, B-1 is holding the ball out of bounds when A-2 is charged with an intentional personal foul against B-2 near the end line. The official awards B-2 two free throws and team B the ball on the end line and rules team B has the privilege of running the end line. Is the official correct? | 19 | No | Rule 7 Section 5 Art 7b |
| 20 | While A-1's try is in flight, A-2 and B-2, at the top of the semi-circle are charged with a double personal foul. The try is unsuccessful. Official resumes play with the alternating possession procedure nearest to where the ball was located when the double personal foul occurred. | 21 | A-1 is confused and attempts to score at the wrong basket. Prior to releasing the ball, A-1 is fouled by B-1. The ball enters the basket. Official counts the goal and awards A-1 a free throw for being fouled in the act of shooting. | 22 | During an alternating possession throw-in by A-1, A-1 places the ball through the plane of the boundary line. B-1 grabs the ball resulting in a held ball. Official awards the ball back to team A and rules this is still an alternating possession throw-in. Is the official correct? | 22 | Yes | Rule 6 Section 4 Art 4, Rule 4 Section 42 Art 5 |
| 23 | Four minutes prior to the start of the game, the coach of team A requests the scorer to add a name to the squad list. The scorer notifies the official and team A is assessed with a technical foul. Later in the game, the scorer notifies the official that A-6 and A-7 have identical numbers. Official charges team A with another technical foul. Is the official correct? | 23 | No | Rule 3 Section 2 Art 2, Rule 10 Section 1 Art 2 Penalty |
| 24 | While A-1's pass is in the air toward A-2, A-3 and B-3 commit a double personal foul. Official resumes play with the alternating possession procedure. Is the official correct? | 24 | No | Rule 4 Section 36 Art 2a, Rule 4 Section 12 Art 2 |

| 30 | A-1 commits his/her fifth foul and is directed to the bench. After notifying the coach, the official instructs the timer to start the 20 second clock and sound a warning horn 5 seconds before time expires to replace A-1. Is the official correct? | 30 | No | Rule 2 Section 12 Art 5 |
| 31 | Time expires in the 4 th quarter with the score tied and the possession arrow favoring team A. The official begins the overtime period with a throw-in by the team entitled to the ball under the alternating possession procedure. | 32 | A-1 in the backcourt passes to A-2. A-2 catches the ball with his/her right foot touching in the frontcourt and the left foot off the floor. | 34 | A-1's throw-in is touched inbounds, but not controlled. While the ball is loose, A-2 fouls B-2. Official rules this a team control foul. Is the official correct? | 34 | No | Rule 4 Section 12 Art 6, Rule 4 Section 19 Art 7, Rule 4 Section 12 Art 1, Rule 4 Section 11 Art 3 |
| 35 | B-1 takes a position directly under the basket before A-1 becomes airborne. Prior to coming back to the floor, airborne shooter A-1 charges B-1. Official charges A-1 with a player control foul. Is the official correct? | 35 | Yes | Rule 4 Section 23 Art 1, Art 4b, Rule 4 Section 19 Art 6, Rule 4 Section 1 Art 1 |
| 36 | While A-1 is holding the ball to attempt a free throw, A-2 commits a common foul. Official rules this a team control foul. Is the official correct? | 36 | Yes | Rule 4 Section 12 Art 1&2, Rule 4 Section 19 Art 7 |
| 37 | Following a score by team A and while the ball is at the disposal of B-1, A-1 breaks the plane of the boundary line. Official issues a warning to team A, awards the ball back to team B and rules team B retains the privilege of running the end line. Is the official correct? | 37 | Yes | Rule 9 Section 2 Art 10 Penalties 1, Rule 7 Section 5 Art 7b |
| 38 | While A-1's first free throw of two is in flight, A-2 and B-2 commit a double personal foul. A-1's try is unsuccessful. Official awards A-1 the second free throw and plays off the made or miss. Is the official correct? | 38 | Yes | Rule 4 Section 36 Art 2b |
| 39 | As the ball comes through the net, A-1 taps the ball away so team B cannot promptly make a throw-in. Official issues a warning to team A. Later in the game, team A delays the game by failing to have the court ready to play following a time-out. Official issues another warning. | 40 | While B-1 is maintaining a legal guarding position on A-1, A-1 contacts B-1 in the torso while B-1 has both feet in the air. Official charges B-1 with a blocking foul. Is the official correct? | 40 | No | Rule 4 Section 23 Art 3a, Rule 4 Section 7 Art 2b |
| 41 | A-1's throw-in is intentionally kicked by B-1 with 10.5 seconds on the game clock. The timer starts the clock. Official instructs the timer to reset to 10.5. Is the official correct? | 41 | Yes | Rule 5 Section 10 Art 1 |

| 44 | A-1, while holding the ball, is straddling the division line. A-1 lifts the foot from the backcourt and then starts a dribble by bouncing the ball in backcourt. | 45 | While A-1 is dribbling, the ball hits B-1's foot and bounces away from A-1. A-1 recovers the ball by catching it and starts a new dribble. Official rules this a legal play. Is the official correct? | 45 | Yes | Rule 4 Section 15 Art 4d, Rule 9 Section 5 Art 2 |
| 46 | A-1's try is touched on its upward flight. Time expires as the ball is in flight. The ball enters the basket. The official disallows the basket. Is the official correct? | 46 | No | Rule 4 Section 41 Art 4, Rule 5 Section 1 Art 1 |
| 47 | B-1 is directed to the bench because of blood on his/her uniform. The official directs the timer to start the 30 second clock to replace B-1. Is the official correct? | 47 | No | Rule 2 Section 12 Art 5, Rule 10 Section 5 Art 3 |
| 48 | Following a score by team A and prior to the ball being at the disposal of team B, a double technical foul is committed. Possession arrow favors team A. Official awards the ball to team B for a throw-in. Is the official correct? | 48 | Yes | Rule 4 Section 36 Art 2b |
| 49 | Team A is wearing white jerseys with each player wearing black headbands and beige wristbands. Official rules that team A must wear the same color headbands and wristband. Is the official correct? | 49 | Yes | Rule 3 Section 5 Art 3a |
